Major Developments

- PRK
 - Large ~450-room site opened downtown
- MSEP

Highlights from Judge Carter's Preliminary Injunction

- Focus: individuals who live near freeway overpasses, underpasses, and ramps
 - 6,000-7,000 in the County of Los Angeles;
 - 3,000-4,000 in the City of Los Angeles; and
 - 200-300 of whom live in unincorporated areas.
- Order: Unless the parties reach an acceptable alternative, then effective May 22nd, the City and County of LA <u>must begin to humanely relocate this population away from freeway overpasses</u>, <u>underpasses</u>, and ramps by providing shelter—or alternative housing options, such as safe parking sites, or hotel and motel rooms contracted under Project Roomkey—to individuals experiencing homelessness.
 - All shelters and alternative housing options must have nursing staff who, upon intake, can test each homeless individual for communicable diseases and other health conditions.
- **Rationale:** Without intervention, there is likely irreparable harm from exposure to environmental pollutants and vehicular or earthquake injury.

- □ The PRK population is more vulnerable than the broader homeless population
- The 65+ population has the same VI-SPDAT score distribution as the rest of the PRK population, and they have a lower-than expected level of chronic homelessness - their age is THE vulnerability factor.
- 90% report having a physical disability; 90% say they have a chronic medical condition; and 50% say they have a mental health issue
- ~60% of the overall PRK population were served by neither DHS nor DMH during the two years prior to their program start dates, which means they are either getting their needs met in the private system or not at all.
- There may be an underrepresentation of hispanic/latinx adults in the older populations at PRK
